Steering of the Financial Stability Authority and the Financial Stability Fund

The Director General of the Financial Stability Authority is appointed by the Finnish Government. The Government has appointed Mr. Jaakko Weuro as Director General for the Financial Stability Authority for the term of office starting on 1 January 2024 until 31 December 2028.

In accordance with the Act on the Financial Stability Authority (1195/2014), the Financial Stability Fund is managed by the Financial Stability Authority.

Board of Directors

The Board of Directors of the Financial Stability Fund is appointed by the Ministry of Finance.

The Board's tasks are limited to the tasks stated in the Act on the Financial Stability Authority (1195/2014). The Board decides upon Fund's risk management, investment planning and principles, and directs the investment of the assets. The Board prepares the investment plan for the Fund's assets.
